Intersection of Aging and Disability

- Aging into disability or with lifelong disabilities: Need to bridge aging and disability systems
- □ Similarities between systems:

Marginal/undervalued populations; underfunded; reliance on family caregivers; focus on self-determination; desire to remain home and in the community

Differences between systems:

chronological vs. functional; person-centered vs. program-driven; large numbers of unidentified participants in aging; funding mechanisms





Public Policy on Aging and Disability

- Lagging public policy and the role of coalitions as de facto policy
- Newness of aging with lifelong disabilities; historical non-intersection and different priorities of the systems, increasing longevity
- Differences between currently older and younger cohorts with lifelong disabilities
- Intellectual Developmental Disabilities and Dementia (esp. for persons with Downs Syndrome)
- Lack of identifier for IDD or onset of disability in national databases



Policy and Practice Implications

- Bridging Aging and Disability (ACL leading the way at the federal level)
- Build relationships across disability and aging providers at the federal, state, and local level
- Build stronger advocacy network for aging
- Find common agendas for legislative advocacy (caregivers, home and community based services, technology, etc.)
- Tread lightly; both sides have much to learn from each other
